
College Tie-up

Deliverables by TGS − (attainable by the Institution)

Techno Gravity Solutions shall provide the following to your Institute. The chart is a summary of every offering as part of the tie-up with your Institute. Details of each have been further provided.



1) Concession* on educational services

We shall conduct/provide our educational training at a concession. The concession as well as the availability of any educational training shall vary according to the resources available; it shall be conveyed well in advance. Additionally, the concession can be availed 'n' no. of times, where, $n = the\ no.$ of times a workshop/seminar is being held at the Institution as part of the tie-up. Range of concession depends on the training/service in consideration.

- a) Workshops
 Concession of 5-10% availed on any workshop. Any other discounts are not included.
- b) Hands-on Concession of 15-20% availed on any Hands-on. Any other discounts are not included.
- c) Event Management
 Assistance will be provided in organization & management of technical competitions.

2) No Limit approach

We shall provide our educational services to any no. of participants. There shall be no lower/upper limit consideration by TGS.

3) Assistance

-Before & during any event/competition/tech-fest; Judging for the same.

The extent of our assistance must be negotiated well in advance such that resources shall be made available at the right time. Track layout, design, rules layout or any human resource help; TGS shall put in best efforts. This shall be devoid of any financial transaction.

4) Prizes

-In sponsored events during Tech-Fest & competitions after a workshop/seminar.

This case is true only-if the name of TGS is affiliated to any event/tech-fest. Prizes shall be at the behest of TGS and in no case be influenced by the partnering council/organization. TGS in its own domain shall provide worthy prizes for the winners. TGS may even voluntarily opt for sponsoring prizes for any creditable event in regards of TGS; it shall be conveyed in advance.

5) E-Publicity

Of events, workshops, Tech-fest of the partner association on the website as well as through email flyers to our database & visitors. TGS shall also provide print space in its newsletter in the respective period of time. TGS in its own regards shall help in publicising the parent event/tech-fest of which information must be presented well in advance.

6) 'Tech-Mate' Club

TGS shall offer membership of the Tech-Mate club to all the members of the partner organization. With such privilege, any member will be able to avail most of the TM benefits*

7) Certificates

TGS shall provide its own certificates to the participants in all its competitions/events in coordination with the partnering council.

8) Miscellaneous


TGS shall strive to provide concession/discounts for other services of associated partners of TGS which shall vary from time to time.

TGS may also setup a complete robotics event, take seminars at concessional rates or at no cost, depending on type of resources required & based on availability.

*a tech-mate card will be required to avail all benefits; which shall be given only after their first purchase at TGS Robo-shop.

➤ <u>Deliverables by associated council/organization</u> – (attainable by TGS)

The Institute shall provide the following to Techno Gravity Solutions as part of the Tie-up. The chart is a summary of every offering as part of the tie-up with your Institute. Brief details of each have been further provided. Note: - This will not incur any cost to the Institute.



1) Sponsor Benefits

TGS shall be de-facto sponsor, either 'Main sponsor' or 'Co-sponsor' as subjective to the Tech-fest &/or individual events of the partner council/organization. TGS will acquire the respective sponsor rights as attributed by the institution.

2) Publicity

TGS requires prior permission for banners & posters to be displayed across the campus; and to enroll members to the Tech-Mate club. TGS shall also require a link on the website (if any) of partnering council, which may well be bartered as per the requirement. TGS may require publicizing any of its allied services & it shall be provided the rights to do so.

3) Stall

TGS shall be provided with prior permission to setup stall *during* the event/competition/tech-fest. Space allocation shall be discussed prior to a week before the event date.

4) Privileges to our members

Includes free/discounted entry for Tech-Mate Club members to any paid event of the partner council or the ones wherein it is a partner. Other benefits shall be negotiated as per necessity.

5) Database


TGS requires the database of the students who are members of the partnering council / organization. It may be presented within a 30 days of the date of tie-up sign-in.

6) Print Space

TGS requires print space in the publicity materials like brochures, banners, posters, flyers etc. for the events/competitions/tech-fests which is associated with the partnering council. TGS also requires print space in the annual newsletter of the partnering council. The amount of such space must be prior committed.

Stipulations

- A minimum of 1 slot in each semester must be provided to avail our educational training.
- A representative governing tie-up with every associated organization will be formed for smooth functioning of all elements.
- The Tie-up structure will be governed by 'Tie-up t&c' of managing body TGS.
- The terms and conditions & MOU will be signed with the associated organization & TGS.
- No personal concessions will be allowed, unless part of any scheme of the club.
- An 'Acknowledgement' letter must be presented for every event partnering us.
- The partnering council must pledge to work only with TGS for the period of time it has tiedup. In that period of time it shall not associate them with any other council.
